Law for SMEs – Part One

Course Description: This is a half-day course covering what employers are required to provide employees by law and will cover Terms and Conditions of Employment, types of contracts that employers can have (including hybrid and flexible terms). It will also cover how you go about changing Terms and Conditions if you need to and what we know so far about the changes that might be coming our way under the proposed new Employments Rights Bill and how that might impact employers.

30 April **First Aid for Mental Health**with Jo Polden 9.00 -12.30

Course Description:

This half-day course is aimed at providing learners with the knowledge to identify suspected mental health conditions and the skills to start a conversation and be able to signpost the person towards professional help.

- Identifying mental health conditions
- Providing advice and starting a conversation
- Stress
- Mental health conditions



Course Description:

This is a half-day course covering how employers can effectively manage absent employees. It will explore how to deal with short and long term absence legally and provide an understanding of how the protected characteristic of Disability applies to absence management. It will also explore how the new proposed Employments Rights Bill might impact employers in this area, and the steps they can take early to minimise that impact.



Course Description:

The QA Level 3 Award in Emergency First Aid at Work (RQF) qualification is designed for individuals who wish to act as an emergency first aider in their workplace. Upon successful completion of this qualification, candidates will be equipped with the essential skills needed to give safe, prompt and effective first aid in emergency situations.

What is more, as a regulated qualification, employers can book this course for their employees and rest assured that they have fulfilled their legal responsibilities for providing quality first aid training, without having to undertake any lengthy due diligence checks.

The roles and responsibilities of an emergency first aider; Assessing an incident; Managing an unresponsive casualty; CPR and defibrillation; Recovery Position; Choking; Seizures; Shock Wounds and bleeding; Minor injuries; Cuts, grazes and bruises; Minor burns and scalds



Course Description:

This is a half-day course and will cover the topic of dealing effectively with Disciplinary and Grievance situations in the workplace, so that employers can do the best they can to avoid a claim for unfair dismissal. We will also cover Redundancy - how to do it right, and how the proposed Employment Rights Bill may impact in these areas.
